A 2013 bill allowed Dominion to expenses in only one year \$400 million that would typically be recovered over longer periods, artificially reducing overcharges and impeding a rate cut. The SCC estimated that rates were set to overcharge by \$280 million annually.

Additionally, SB 1349 prohibited a rate cut in the 2015 rate review.
